Red-checkered tablecloths greeted guests at the 10th annual President's Event hosted by the Greater Cedarburg Foundation on Saturday, Oct. 17, at the Cedarburg Cultural Center. A total of 155 people attended the party, which raised more than \$35,000 to support the Foundation's mission.

The event had a picnic theme, complete with lawn games, burgers and ice cold beer. "We thought it would be fun to have a picnic theme this year since funds raised are supporting the band shell project in Cedar Creek Park," said GCF President Chris Smith.

The aging band shell is undergoing a

major reconstruction, thanks in part to a \$200,000 gift from the Greater Milwaukee Foundation (GMF) in celebration of its 100th anniversary. "We wanted to support the generosity of the GMF with a gift of our own," said Smith who noted that fundraising for the band shell project is a unique community partnership between the Cedarburg-Grafton Rotary Club, the GCF and the GMF. "The success of this event shows our commitment to this project."

Guests were given the opportunity to bid on a variety of auction items including two Adirondack chairs

Grant Spotlight ... Ozaukee County Historical Society's Pioneer Village

This past year, the Greater Cedarburg Foundation awarded more than \$47,000 in grants to 10 area non-profit organizations as part of its annual grant cycle. One of those grant recipients, the Ozaukee County Historical Society, is using the money to help with the construction of a multipurpose facility at Ozaukee County Pioneer Village, a living history museum the society owns.

Established in 1962 on 10 rolling acres just north of Hawthorne Hills Park, Pioneer Village showcases over 20 historic structures that have been removed from their original home sites in Washington and Ozaukee Counties and have been fully restored and furnished in period style.

Ozaukee County Pioneer Village is open to the public from May to October. Thousands of visitors come each year to step back in time and experience life in rural Ozaukee County between the late 1800s and early 1900s. School tours are scheduled in May and October for area public and private elementary schools. Children learn about what it was like to attend a one-room schoolhouse, the hardships and chores of everyday life and how the Trading Post served as a store, post office and polling place. There are several special event weekends, scheduled throughout the summer, that focus on historic demonstrations, military service, farming, music and children's activities.

As time passed, visitors started to expect some modern amenities, such as indoor plumbing. Some schools and senior bus tours had declined to come to Ozaukee County Pioneer Village without indoor/ ADA compliant restrooms. Many opportunities for weddings and celebrations also were lost because there were no indoor modern facilities.

More than 10 years ago, the OCHS board drew up plans for a historically fitting two-story building that would have all the

modern conveniences, gift shop, meeting rooms and hall with a price tag of over \$1 million. To raise that amount of money back then seemed like an overwhelming task, so the project was tabled until later.

In 2014, the current board, still feeling the demand of its patrons and a need for increased utilization, established the following goals including:

- Increasing the number of months the village is open
- Increasing the number of school and senior tours
- Offering year-round educational programs and exhibits
- Increasing the number of major events held each year

OCHS decided to move forward with building an affordable, practical and functional facility with heating, air conditioning, ADA compliant restrooms, new food service area and gathering hall, what is now called "The Pioneer Village Hall". Work began on the Pioneer Village Hall in March 2014. The electric service was completely upgraded, new water lines were trenched in, cement work was finished and rough building was constructed. In 2015, the modern restroom facilities and new food area were completed. The stonework on the exterior of the building was just finished in October, and the exterior wood siding will be done before the end of the year, weather permitting.

Mary Ann Velnetske, a OCHS board member, expressed her appreciation for the grant money from the Foundation, which she said was used to complete the new epoxy floors in the restrooms. "The epoxy floor material was chosen because it looks nice and is very durable and easy to clean," she said.

The next phase of construction will be completing the lighting, interior walls and flooring. The final phase will be the heating, air conditioning and audio-visual equipment for meetings and programs. A \$50,000 reserve is being planned for future maintenance.

Approximately \$150,000 of the \$300,000 budget has been spent to complete the work thus far. Private donations have been

received from OCHS members, individuals and area businesses. In-kind donations have been received in the form of labor, building materials, landscaping trees, backfill, topsoil and a hot water heater.
