More than 200 people attended the 11th annual President's Gala on Saturday, Sept. 24, at the Ozaukee Pavilion at the Ozaukee County Fairgrounds and the results were impressive. About \$70,000 was raised to support the Foundation's mission to provide private

"This was exactly the kind of evening I had hoped for ... good company, good food, good entertainment and a great reason to come together," said Foundation President Joe Fazio. "I was thrilled to see so many people come out and support the Foundation and the good work that we do."

GCF Launches Annual Fund Drive

The Greater Cedarburg Foundation has launched its Annual Fund Drive for 2016 as it continues to provide financial support for projects undertaken by local non-profit organizations.

2016 has already been a historic year for the Foundation. Together with The Greater Milwaukee Foundation, we granted \$250,000 toward the construction of a new band shell in Cedar Creek Park in Cedarburg. In addition, for the first time in its history, the Foundation recognized an organization, the Cedarburg Fire Department, as the recipient of its annual Civic Award in honor of the Department's 150th anniversary.

Grant Spotlight ... Mel's Charities & Riveredge Nature Center

This past year, The Greater Cedarburg Foundation awarded more than \$56,000 in grants to 11 area non-profit organizations as part of its annual grant cycle. We asked two of those recipients, Mel's Charities & Riveredge Nature Center, to tell us how that money has helped them reach their goals.

Mel's Charities

Since 1999, Mel's Charities has donated over \$700,000 to special needs organizations, human services and scholarship opportunities. Mel's hosts a series of six annual fundraising events: a pig roast, a run/walk, a golf scramble, a slow pitch classic, a Lakeshore Chinooks game and an 8-pin tap event.

The success of each event depends on having supplies in an organized place, according to executive director Tom "Mel" Stanton, who applied for a grant from the Greater Cedarurg Foundation to help purchase organizational totes, cooking equipment, a small refrigerator/freezer, folding tables and a new larger trailer.

"The 2016 grant we received provided

us the means to help purchase a much needed trailer. This allows us to store and organize our supplies in one location! No more storing items at different locations. We can now pull up to our events, drop the trailer door and be ready to have 'Great Times for Great Causes'!," said Tom. "With new equipment and better organizational capacity at all of our fundraising events, Mel's will be more successful in giving back."

Riveredge Nature Center

The Scientist in Residence program, through Riveredge Nature Center, was introduced to the Cedarburg School District during the 2016-17 school year thanks to a lead grant from the Greater Cedarburg Foundation. The goal of the program is to create school systems where the outdoors is interconnected to daily learning and nature is the inspiration for the next generation of scientists, according to Jessica Jens, executive director of Riveredge Nature Center.

As the second school district in the state to be part of this innovative private-public

partnership, the Cedarburg School District has focused year one on the Middle School staff and students. The Scientist in Residence (SIR), Jamie Dins, listens to and responds to staff in order to help the outdoors become integrated throughout the curriculum.

"We are confident that the SIR program will achieve meaningful results," said Jessica. During the first two months of the school year, the Cedarburg School District SIR had already logged over 1,000 student and 27 teacher contacts. Some examples of the SIR work include assisting with an off-site field trip focusing on wetland ecology to co-teaching a communication arts class connecting nature to what students are reading.

According to Jessica, research shows that students who learn outdoors experience mind, body and spiritual benefits, improved critical thinking, reduced ADHD symptoms, higher standardized test scores, increased fitness levels, improved distance vision, raised Vitamin D levels and reduced stress.
